1. Scope of Services

These Terms govern advisory, consulting, coaching, strategic planning, and session-based engagements only. They do not govern website design and implementation, digital presence builds, systems and workflow implementation, digital asset production, or any other engagement or purchase in which Althea Ra Consulting Corp produces a defined deliverable. That work is governed by the Althea Ra Consulting Corp. Project & Implementation Terms and by the applicable proposal or statement of work. Where a single engagement includes both advisory work and defined-deliverable work, the applicable proposal or statement of work must state which portions are governed by which document, and where it is silent, these Terms govern the advisory portion and the Project & Implementation Terms govern the defined-deliverable portion.

2. Nature of Engagement

All services governed by these Terms are advisory-based and designed to provide clarity, structure, and strategic direction.

3. Payment Terms

All services must be paid in full in advance unless otherwise agreed in writing. All payments are non-refundable. Payment secures advisory time, expertise, and intellectual contribution, not outcomes. This section applies to advisory engagements governed by these Terms. Payment structure and refund treatment for defined-deliverable work, including any payment received for defined-deliverable work where no proposal or statement of work has been accepted, are governed by the Project & Implementation Terms and the applicable proposal or statement of work, in the manner those terms provide.

4. Session Structure

Sessions begin and end at the scheduled time. Additional time, follow-up work, or extended advisory requires a separate booking or upgraded engagement.

5. Scope and Boundaries

Each engagement is limited to the defined scope of the selected service. Additional deliverables, expanded scope, or ongoing advisory require a separate agreement.

6. Intellectual Property

All frameworks, methodologies, language, and strategic models remain the exclusive intellectual property of Althea Ra Consulting Corp. Clients are granted limited, non-transferable rights for internal use only and may not reproduce, distribute, or resell materials. This section applies to materials provided in advisory engagements governed by these Terms. Ownership of, and the client's rights in, deliverables produced in defined-deliverable work are governed by the Project & Implementation Terms.

7. No Partnership or Joint Venture

Participation in any engagement does not establish a partnership, joint venture, or ownership relationship. Any such arrangement must be defined in a separate written agreement.

8. Client Responsibility

Clients are solely responsible for all decisions, actions, and implementation. Results depend on execution, decision-making, and external factors outside the control of Althea Ra Consulting Corp.

9. Confidentiality

All client information will be treated as confidential and will not be disclosed without consent, except where required by law. Where an engagement includes defined-deliverable work, the confidentiality provisions of the Project & Implementation Terms govern the handling of information in connection with that work.

These Terms are governed by the laws of the State of New Jersey.

Purchase of, or payment for, defined-deliverable work constitutes agreement to the Project & Implementation Terms and to the applicable proposal or statement of work rather than to these Terms.
